

**CODE OF CONDUCT
AFTERSCHOOL PROGRAM**

The Code of Conduct has been prepared to help your child experience a successful enjoyable time at the Oneida Recreation Afterschool Program. Please take the time to read over the Code of Conduct carefully and go over them with your son/daughter. Parents should promote cooperation and agreement between the home and the Afterschool Program.

1. It is expected that each and every one participating demonstrate appropriate behavior. The Rec. Center Staff are in charge and have the authority to make the decisions pertaining to inappropriate behavior.
2. Participants are not to use profanity or vulgar language. Swearing will not be tolerated.
3. All participants will be respectful of each other and the Rec Center staff and exhibit good sportsmanship at all times.
4. If a participant becomes aware of a situation regarding drugs, alcohol, fighting, property damage, theft, etc. Or has information regarding such, he/she is requested to report it to a Rec. Center Staff member.
5. Anyone caught possessing or distributing drugs, alcohol, tobacco or related paraphernalia, harassment, threatening, stealing or vandalizing, the police will be called immediately and your parent/guardian will also be contacted.
6. It is highly recommended that you leave your personal electronic devices or large amounts of money at home. If you choose to bring them to the Teen Center/Lounge the Rec. Dept. will not be responsible for anything that is lost or stolen.

Discipline at the Afterschool Program will be administered with firmness, fairness and consistency.

In all cases the following consequences will happen:

Violation #1--Each incident will be written up and kept on file and a warning will be given.

Violation #2--The Teen will be written up and participant will be asked to leave for the rest of the day.

Violation #3--Depending on the severity of the violation the participant maybe suspended for a period of time appropriate to the violation. The suspension will be determined by the Recreation Director. Also, parent/guardian will be contacted.

I, release, discharge and agree not to sue the Oneida Recreation Department, The City of Oneida, claim, damages, cost or cause of action which I have or may in the future have as a result of an injuries or damages sustained or incurred by my child from whatever cause including but not limited to the negligence, breach of contract or wrongful conduct of the parties hereby released.
